Club Dues are billed electronically at the beginning of each month. Any account 15 days past due will initiate payment of the annual contract and suspension of membership until payment has been received.

AUTHORIZATION FOR PAYMENT OF MONTHLY DUES AND ANCILLARY CHARGES - ELECTRONIC BANK DRAFT OR MONTHLY CREDIT CARD I authorize Sandstone C.C. (SSCC) and my financial institution to deduct the amount of my monthly dues, and any charges made to my membership account, from the account information identified by providing to SSCC whether in person, via this agreement, or directly into an approved SSCC 3rd party point of sale system. Members must have at least one form of payment on file during the duration of membership. I understand my automatic payment will be deducted on or about the 1 day of each month. If the 1st falls on a weekend or bank holiday, the deduction will be drafted on the next business day. Changes in account or bank information must be completed online through the customer portal by the 10th of the month for it to be processed correctly on the 1ST. Canceling a bank draft does not cancel a membership or cancel charges accrued on the membership account. In the event that a bank draft is revoked, or an account is closed, and new bank information is not received, the membership may be transferred to the "annual payment" option and the remaining amount due under the terms of the Membership Contract will be owed.
